Welcome and introductions

Members welcomed and congratulated James Kay, Judge Executive. Visitors were present at the meeting, so introductions were made.

Approval of Minutes

Minutes were accepted, with correction of date noted on p2.

Report from the Nominating/Executive Committee

Lisa Johnson/Sarah Mudd

Lisa made a motion to replace Amanda Goforth, permanent voter, with DeShawn Freeman both from Bluegrass.org. Lisa nominated Rob Young (VPD) to be a non-permanent voter. The Executive Committee proudly announced they asked Nancy Blackford to be the new ASAP Coordinator and she accepted. Motion was made to accept requests for all by Lisa Johnson, since it was coming from the Executive Committee a second was not needed. Motions carried.

OP OUT Grant Update

Nancy Blackford/Lisa Johnson

Nancy thanked the OP-OUT committee (Wesley, Lisa and Nancy) for the success in getting the grant approved and the program fully funded. Nancy stated OP-OUT is a recovery support program to compliment and work with other agencies in the county that treat and prevent substance abusers from relapsing. She then made a plea to the Board for their support to help make this a success by getting the word out to the community. Lisa continued with the update stating the goal and mission for OP-OUT. Lisa also announced the new part-time director, Jim Bush from Bluegrass.org. Jim Bush spoked about his background experiences, skills and the goals for the grant. Lisa informed the Board we are now in the process of hiring a Peer Support Specialist. Lisa asked the Board to help get 12-15 applicants from Woodford Co. to sign up for the program. Lisa stated the applications have already been sent to The Nile, Isaiah House, ARC, Infinity Center. Nancy stated she has sent information to Judge Brian Privett of the Drug Court. Questions asked:

- 1. James Kay asked about confidentialy and Lisa informed us that there is a statement on the application for participants to sign to meet that requirement.
- 2. Mae Collins from the Nile asked whether the OP-OUT program is limited for opioid abuse only? Group discussed and all agreed the program can accept others (Meth, Heroin) that meet the criteria (i.e. been in treatment and sober for at least 30 days).
- 3. Rob Young stated they are seeing more Meth abuse and help is needed.
- 4. Larry Blackford asked Rob Young, if he had a record of what ethnicities are using drugs? Rob stated there is no record of ethnicity, just across the board, affects all income levels, all ethnicities.
- 5. Julie Snawder asked how many absences can they have in OP-OUT? Lisa stated, if they missed two consecutive meetings without a valid excused absence, they can be dismissed. Our goal is not to dismiss but to encourage, but there does need to be a "consequence" for non-attenders.
- 6. Rob Young asked what will happen if they relapse while in the program? Wesley Scott stated that their one year "drug free" will be reset for them. They can stay but will not "graduate". Maybe they can re-enter (or stay involved) for the next one-year program. These things can be decided as the pilot progresses.
- 7. Mae Collins asked if will there be transportations to these meetings? Lisa & Nancy stated they are in process of finding out from participants and then will work on finding transportation as needed. Larry Blackford suggested asking churches. Cassie Prather said the Health Dept. can offer gas cards.

Elizabeth Coots thanked the Op-OUT Committee for job well done. Lisa Johnson ended by sharing that there will be incentives to help the OP OUT participants stay with the program (ex.free passes to Falling Spring, etc)

Leadership/Achiever Scholarship

Lisa Johnson asked for a new Scholarship Review Committee, and Sarah Mudd agreed to chair. DeShawn Freeman and Julie Snawder agreed to review scholarship applications in early March.

- Rob Young asked Cassie Prather if they have gone to retractable needles? Cassie said not yet, have
 not purchased any new needles. Cassie will purchase one-time retraction needles with this year's grant
 money. Rob stated the need for this has gone down.

Main goals are to educate the Fiscal Court, make an assessment of everything available to help our community, individuals and families, in a way that help us all. He expects to have an official report to the Fiscal Court in May.

Mae Collins announce the Nile is looking to hire Therapist Counselors.

Emily McCarthy shared fliers from Bluegrass.org and has information on Fayette Co. Drug Assessment.

Wesley Scott announced there will be another "On the Table Talk" hosted by LAC and others.
